I. INFORMATION IN ACCORDANCE WITH THE PROVISIONS ESTABLISHED IN THE SPANISH ORGANIC LAW ON PERSONAL DATA PROTECTION

1. PRINCIPLE OF THE INFORMATION

In accordance with the provisions established in Article 5 of Spanish Organic Law 15/1999 of 13 December on Personal Data Protection (hereinafter LOPD), we hereby expressly, accurately and distinctly inform you that the data you provide in the forms available on our website or any other channel for collection information, as well as those produced during your relationship with our organisation shall be subject to processing in the files for which **ESTUCOS IBIZENCOS ORIGINALES S.L.** is responsible, duly notified in the Spanish Data Protection Agency's General Data Protection Registry, with the aim of maintaining and fulfilling the relationship of the service recipient with our organisation and providing services derived thereof.

Similarly, in accordance with the provisions established in the cited LOPD and Spanish Law 34/2002 of 11 July on Information Society Services and Electronic Commerce (hereinafter LSSI-CE), we hereby inform you that your data may be used to send you commercial and courtesy communications related to our organisation via telephone, post, fax, email or equivalent methods of electronic communication.

Likewise, we inform you that your data will be transferred in all cases where it is necessary for the development, fulfillment and control of the relationship of the service recipient with our organisation and in circumstances that it is authorised by a regulation having the force of law and, in particular, when one of the following situations occurs: a) The purpose of the processing or transfer is to fulfil a legitimate interest of the controller or transferee protected by the aforementioned regulation.

b) The data processing or transfer is necessary so that the controller fulfills the duty imposed upon him by the aforementioned regulation.

1. PRINCIPLE OF CONSENT

Consent to process their data for the purposes described in the previous paragraph will be understood as granted by marking the corresponding box for such purposes on our website.

2. OBLIGATORY NATURE OF DATA REQUESTED

It is compulsory to complete each and every field appearing on the forms on our website (otherwise, the fields that are compulsory will be marked with an asterisk). Failure to provide your data means that it is impossible to maintain and fulfill the relationship between the service recipient and our organisation, as this data is necessary to provide services derived thereof.

3. DATA QUALITY PRINCIPLE

The service recipient will be the only person responsible for the veracity and accuracy of the data provided. **ESTUCOS IBIZENCOS ORIGINALES S.L.** shall act in good faith as a simple service provider.

In the event that the service recipient provides false data or the data of a third party without their consent to do so, they will be liable to AGROTURISMO SA MARINA S.L, the affected or interested parties, the Spanish Data Protection Agency and, where appropriate, regional data protection authorities, for the responsibilities derived from these circumstances.

ESTUCOS IBIZENCOS ORIGINALES S.L. does not collect data from those under fourteen years of age through its website. In the event that a person under the age of fourteen provides their data through the forms available on our website or any other channel for data collection, this data will be immediately destroyed as soon as we are aware of these circumstances.

In order to comply with the provisions established in Article 4.3. of the LOPD, the service recipient undertakes to inform **ESTUCOS IBIZENCOS ORIGINALES S.L.** of any changes to their data, so that they are true to their current situation at all times.

4. DATA SECURITY PRINCIPLE

ESTUCOS IBIZENCOS ORIGINALES S.L. undertakes to fulfil its duty of confidentiality with respect to personal data and its duty to store it and shall adopt all the technical and organisational measures required to guarantee its security and avoid its unauthorised alteration, loss, processing or access, taking into account the state of the technology, the nature of the data stored and the risks to which it is exposed, whether through human action or physical or natural influences, implemented by Title VIII of Spanish Royal Decree 1720/2007 of 21 December 2007 approving the Regulation implementing Spanish Organic Law 15/1999 of 13 December 1999 on Personal Data Protection.

5. EXERCISE OF RIGHTS

In accordance with the provisions established in the LOPD and Spanish Royal Decree 1720/2007 of 21 December 2007, approving the Regulation for its development, the service recipient may,
